

I may contact the Fund to revoke my consent. I agree to notify the Fund of any errors or discrepancies within 45 days after the date of the statement confirming a transaction. The statement will be deemed to be correct, and the Fund and its transfer agent shall not be liable if I fail to notify the Poplar Forest Partners Fund within such time period. I certify that I am of legal age and have the legal capacity to make this purchase.
